Assistant Dean of CKGSB and Chief Representative in Europe, Bo Ji, will lead the course content delivering unparalleled insight on the Chinese economy, political environment and demographics to bring advisors completely up to date with the latest trends. He will also provide insight on soft skills required to deal with Chinese professionals and business leaders: from cultural norms and practises to the art of negotiation.
